Hereby register for the Caversham Higher Certificate in ECD Course

I understand and accept that I

- Have a matric (Grade 12), an ECD certificate at NQF level 4 (certified copy attached) or have at least 5 years of teaching experience and qualify for matric exemption.
- Have access to a preschool class or small group of young children
- Attend all lectures, and where one is missed to make arrangements to “catch up”. That an attendance of 80% of lectures (workshop sessions) is mandatory.
- Complete all written assignments within the required time frame.
- Keep a portfolio of my own and learner’s work and provide a testimony of the impact the Caversham Course has had on my life
- Pay the once off administration fee of R1,500 on registration.
- The total annual course fee is R 13,000 per year
 - Option 1. Monthly payment by EFT or Direct Deposit at the Bank of R1,300.00 per month over 10 months (February to November) By the end of November all fees are to be fully paid.
 - Option 2. Full payment of fees by end February will qualify you for a 10% discount.
 - Option 3 To open a Stop Order for R1,300 per month for 10 months
- Should any student leave during the year a month’s written notice and a month’s fee is required.
- Should fees not be kept up-to-date Caversham has the right to
 - Stop attendance of the course
 - Refuse notes
 - Refuse to undertake any assessment, including the marking of assignments and workplace assessment
 - Not submit your portfolio of evidence to National Seta for verification
 - Withhold your certificate, if issued, until outstanding fees are paid
 - Pursue legal measures

I further understand that

- Credits from the Higher Certificate are not recognised by universities
